CERTIFICATE OF INCORPORATION

THE HOBBY-MACHINIST, INC.

Under Section 402 of the Not-for-Profit Corporation Law

FIRST:

The name of the Corporation is:

THE HOBBY-MACHINIST, INC.

SECOND:

The Corporation is a Corporation as defined in subparagraph (a)(5) of Section 102 (Definitions) of the Not-for-Profit Corporation Law.

THIRD:

The purpose or purposes for which the Corporation is formed are as follows:

The purpose of the Corporation is to plan, organize, and host an internet forum (web site) to promote and advance the hobbies of machining and metalworking; to demonstrate to members of the forum, including hobby machinists, home shop machinists, novices, and members of the general public, ways to operate machines safely and productively; to assist those interested in entering the hobbies to acquire knowledge of machining and metalworking; to bring machinists and metalworkers of all levels, and those interested in learning the hobbies together to exchange ideas and provide an educational environment.

FOURTH:

In furtherance of its corporate purposes, the Corporation shall have all the general powers enumerated in Section 202 of the Not-For-Profit Corporation Law, together with the powers to solicit grants and contributions for the corporate purposes.

FIFTH:

Nothing herein shall authorize this Corporation, directly or indirectly, to engage in or include among its purposes, any of the activities mentioned in Not-For-Profit Corporation Law Section 404(b) through (u).

SIXTH:

The Corporation shall be a Type B corporation pursuant to Section 201 of the Not-For-Profit Corporation Law.

SEVENTH:

The Office of the Corporation is to be located in the County of Queens.

EIGHTH:

The Secretary of State is designated as agent of the Corporation upon whom process against it may be served. The post-office address which the Secretary of State shall mail a copy of any process accepted on behalf of the Corporation is:

TENTH:

The following language relates to the corporation's tax exempt status and is not a statement of purposes and powers. Consequently, this language does not expand or alter the corporation's purposes or powers set forth in paragraph **THIRD**:

Said Corporation is organized exclusively for charitable, religious, educational, and/or scientific purposes, including, for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ELEVENTH:

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a charitable organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a charitable organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) .

TWELFTH:

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, director, officer of the Corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation), and no member, trustee, officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

THIRTEENTH:

No part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code Section 501[h]), or participating in or intervening in (including the publication or distributions of statements) any political campaign on behalf of any candidates for public office.


FOURTEENTH:

In the event of dissolution, all of the remaining assets and property of the Corporation shall, after payment of necessary expenses and satisfaction of all liabilities thereof be distributed to another organization exempt under Section 501(c)(3) of the Internal Revenue Code or to the Federal government, or state or local government for public purposes, subject to an Order of a Justice of the Supreme Court of the State of New York.

FIFTEENTH:

In any taxable year in which the Corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code of 1986, the Corporation shall distribute its income for said period at such time and in such manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; and the Corporation shall not (a) engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code, (b) retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code, (c) make any investments in such manner as to subject the Corporation to tax under Section 4944 of the Internal Revenue Code, or (d) make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code, or corresponding provisions of any subsequent Federal tax laws.
